UNESCO ACCREDITATION PROCESS

Conditions FOR ACCREDITATION

Journalists are kindly requested to demonstrate that they work for a media organization by providing the following documents:

- . A professional press card issued by the CCIJP (for French journalists)
- . A press card issued by the French Ministry of Foreign and European Affairs (for foreign correspondents accredited in France)
- . A letter on the official letterhead of a press organization, signed by the managing editor, for requests by French technical staff without press cards

Journalists for foreign media who do not have French Ministry of Foreign and European Affairs accreditation must present their request - along with a copy of their national press card - by way of the Permanent Delegation to UNESCO of the home country of the media they represent.

On-line media must meet the following requirements:

- . The on-line publication must belong to a registered company, e.g. a press organization, and have a real postal address and telephone number
- . The on-line publication must publish a significant amount of original information, reporting or analysis on international issues

Please note:

Journalists must demonstrate past experience reporting on international issues for the media

Accreditation will not be given to newsletters of non-governmental organizations

You may be asked to provide the last two issues of your publication (for written press), recordings of two recent stories (for radio and television), a letter from the broadcaster intending to air your material (for independent TV production companies), original press clippings and photos with the credits of media that published them (for photographers), or three articles published recently with your by-line (for online media)

UNESCO reserves the right to refuse or cancel the accreditation of journalists affiliated with press organizations whose activities are contrary to the principles of the United Nations Charter; who abuse privileges granted to them; who use their accreditation to reprehensible ends; and whose behaviour is contrary to the Organization's principles or the principles and ethical standards of journalism

UNESCO opening hours: 9 a.m. - 5.30 p.m.

Badges must be worn visibly to facilitate the work of security staff

Additional accreditation may be required on certain occasions
