Subject : UNESCO Conventions Ceremony

Excellency,

I have the honour to refer to the letter dated 8 June 2023, which I have sent, on behalf of the Director-General, to invite your State to participate in the UNESCO Conventions Ceremony to be held at the Organization's Headquarters in Paris, on 10 November 2023, between 2 and 3 pm, on the margins of the 42nd session of the General Conference.

This event provides an opportunity to celebrate UNESCO's standard-setting action, allowing States to reiterate their commitment to the Organization's mandate.

At the Ceremony, representatives of those States having expressed their interest will be invited, in the Director-General's presence, to sign and/or deposit their instruments of ratification, acceptance, approval or accession to the conventions and protocols concluded under the auspices of UNESCO. It is to be noted that, while all conventions and protocols are open for ratification, acceptance, approval or accession, only regional conventions and protocols are open for signature.

For your convenience, a complete list of UNESCO conventions is attached herewith. All additional information pertaining to the Ceremony, as well as the status of ratification and signature of conventions by each State, are available on the page dedicated to standard-setting instruments on my Office's website (https://www.unesco.org/en/legal-affairs). This website also provides templates of instruments of ratification and full powers.

In accordance with the rules of international law, only Heads of State, Heads of Government and Ministers for Foreign Affairs are authorized, in virtue of their functions, to sign a treaty and/or to express the consent of the State to be bound by it by signing an instrument of ratification, acceptance, approval or accession.

These formalities may be carried out by another person, provided that he or she presents the appropriate full powers. In order to be valid, the instrument conferring full powers must contain the following:

- The signature of the Head of State, Head of Government or Minister of Foreign Affairs designating the person vested with full powers;
- The title of the convention or protocol upon which action is to be taken;
- The full name and title of the person vested with full powers; and
- The date and place of signature.

I would be grateful if you could inform me, by e-mail (dir.la@unesco.org) before 29 September 2023 of your State's presence in this event and, if applicable, of its intention to sign and/or deposit instruments of ratification, acceptance, approval or accession to the conventions and protocols of which the Director-General is the depositary.

A copy of the full powers and instruments of ratification, acceptance, approval or accession, together with any reservations and declarations made thereto, must be communicated to my Office by e-mail (dir.la@unesco.org) before 29 September 2023 for verification that these instruments are in due and proper form in conformity with the applicable rules of international law.

I also have the honor to invite you to attend an information session, which will be held on 21 June 2023, during which the conduct of the Ceremony and its modalities will be explained. The Office of International Standards and Legal Affairs remains at your disposal for any supplementary questions you may have.
